

ORDINANCE NO. 278

AN ORDINANCE OF THE BOROUGH OF ALBURTIS ESTABLISHING THE TAX RATE FOR THE FISCAL YEAR 1990.

BE IT ORDAINED BY THE COUNCIL FOR THE BOROUGH OF ALBURTIS AS FOLLOWS:

SECTION I: An annual per capita tax of \$5.00 for the year 1990 be and is hereby levied and assessed on each resident of the Borough of Alburttis, eighteen (18) years of age and over. The provisions of Ordinance 224, Section I, Ii and III are hereby ratified and affirmed.

SECTION II: An annual earned income tax of 1% on the salaries, wages, commissions, compensation and earned income for the year 1990 be and is hereby levied and assessed on each resident of the Borough of Alburttis, eighteen (18) years of age and over.

SECTION III: An annual occupational privilege tax of \$10 for the year 1990 be and is hereby levied and imposed on each individual engaged in an occupation within the corporate limits of the Borough of Alburttis, eighteen (18) years of age and over.

SECTION IV: A realty transfer tax of 1% for general revenue purposes is hereby levied and imposed upon the transfer of real estate or interests in real estate situated within the Borough of Alburttis, regardless of where the documents making the transfer are made, executed or delivered, or where the actual settlements on such transfer took place.

SECTION V: A tax is hereby levied on all assessed property within the Borough of Alburttis subject to taxation, for the fiscal year 1990, as follows:

- (a) For the general borough purposes the sum of 24 mills on each dollar of assessed valuation.
- (b) The total tax rate for general borough purposes amounts to 24 mills.

SECTION VI: Sewer rentals or charges are imposed upon and shall be collected from the owner of each improved property which shall be connected with the sewer system, for use of the sewer system, whether such use shall be direct or indirect, which sewer rentals or charges shall commence and shall be effective as of the date of connection of each

improved property to the sewer system and shall be payable as follows:

Flat rate for each dwelling unit: \$120.00/year

Temporary surcharge for each dwelling unit: 45.00/year

All other sewer rentals or charges shall remain unchanged.

Sewer rentals or charges shall continue to be payable per quarter annum.

SECTION VII: The annual rent or charge for use and consumption of water by all metered users drawing from the water system of the Borough of Alburtis shall be as follows:

- (1) METER CHARGES. A minimum meter charge for the drawing of one (1) gallon to three thousand (3,000) gallons, quarterly, based upon meter size, shall be as follows:

- (2) VOLUME CHARGE. A volume charge based upon total consumption during the quarterly period shall be as follows:

Water Usage (gallons)	Rate
1 - 3,000	\$8.60 per base 3M
3,001 - 8,000	+1.73 M
8,001 - 13,000	+1.89 M
13,001 - 18,000	+2.06 M
Over 18,000	+2.24 M

- (3) SPRINKLER SYSTEM CHARGE. A charge of thirty-one dollars and twenty-five cents (\$31.25) per quarter shall be paid by all resident users of water service maintaining a

fire line independently or in connection with the installation of an automatic sprinkler device system.

(4) NEW UNIT/FUTURE FACILITIES CHARGE. Every consumer of water served by Alburdis water system hereafter obtaining a permit for the installation of a water meter or the conversion of service from a single-unit to multiple-unit service shall be subject to a surcharge of Three Hundred Seventy-Eight Dollars and Twenty-Five Cents (\$378.25) per unit of service. Such surcharge shall be due and payable at the time of installation of a water meter or unit conversion. The proceeds of this surcharge are to be separately maintained in a fund to be used for future water service facilities improvements.

SECTION VIII: A penalty of ten percent (10%) shall be charged for all tax bills not paid within sixty (60) days from the date of billing. An additional penalty of one percent (1%) per month shall be chargeable after the expiration of ninety (90) days without payment; total penalty charges not to exceed thirteen percent (13%).

SECTION IX: Any ordinance or parts of ordinances conflicting with this ordinance be and the same hereby are repealed only insofar as they conflict with this ordinance.
