Ordinance No. 369

(Duly Adopted July 14, 1999)

AN ORDINANCE CREATING A HANDICAPPED PARKING SPACE ON THE EAST SIDE OF SOUTH MAIN STREET, IN THE VICINITY OF 216 SOUTH MAIN STREET; ESTABLISHING RESTRICTIONS; AND IMPOSING PENALTIES FOR VIOLATIONS.

**WHEREAS**, the Pennsylvania Vehicle Code, 75 PA. CONS. STAT. § 3354(d)(2), provides: “At the request of any handicapped person or severely disabled veteran, local authorities may erect on the highway as close as possible to their place of residence a sign or signs indicating that that place is reserved for the handicapped person or severely disabled veteran, that no parking is allowed there by others, and that any unauthorized person parking there shall be subject to a fine”; and

**WHEREAS**, Borough Council has received a request for a reserved parking space for Dalton W. Stoneback, who resides at 216 South Main Street, a handicapped person; and

**WHEREAS**, Borough Council has determined that it is appropriate to reserve a parking space for Mr. Stoneback; and

**NOW, THEREFORE**, be it **ORDAINED** and **ENACTED** by the Borough Council of the Borough of Alburtis, Lehigh County, Pennsylvania, as follows :

**SECTION 1.** A handicapped parking space is hereby created on the west side of South Main Street, extending from the point which is thirty-two (32) feet south of West Stone Alley, to the south a distance of twenty-two (22) feet. No parking shall be allowed in this space by any vehicle other than one which bears an HP or DV license plate, or displays a handicapped person or severely disabled veteran parking placard, issued by the

Pennsylvania Department of Transportation and which is registered in the name of Dalton W. Stoneback or another person residing with him. This provision shall remain in effect until December 31, 1999, unless sooner revoked by Resolution of Council, or unless extended from year-to-year thereafter by an annual Resolution of Council.

**SECTION 2.** The Borough shall erect and maintain a sign in accordance with regulations of the Pennsylvania Department of Transportation to implement the provisions of Section 1, which sign shall state the penalty provided by law for violations, and state that vehicles in violation may be towed.

**SECTION 3.** All violations of Section 1 shall be subject to the penalties provided by 75 PA. CONS. STAT. § 3354(f) and (g).
