Ordinance No. 377

(Duly Adopted December 29, 1999)

AN ORDINANCE FIXING THE SALARIES, BONDS, AND DUTIES OF BOROUGH OFFICIALS AND EMPLOYEES FOR THE YEAR 2000.

**BE IT ORDAINED** and **ENACTED** by the Borough Council of the Borough of Al-  
burtis, Lehigh County, Pennsylvania, as follows:

**§ 1. Salaries and Rates of Compensation.** The following salaries and rates of compensation are hereby established for the year 2000 for the offices and positions of employment set forth below:

Patrol Officer (after 6 months of full-time employment and before 1 <sup>st</sup> anniversary).....	11.98 / hour
Patrol Officer (first 6 months of full-time employment) .....	11.27 / hour

After 10 <sup>th</sup> anniversary of Borough employment .....	12.00 / hour

**§ 2. Fidelity Bonds.** The holders of the following offices shall be required to have fidelity bonds posted with the Borough in the principal amounts set forth below.

Coverage shall be secured and premiums paid by the Borough:

Borough Secretary.....	\$50,000.00
Borough Treasurer .....	50,000.00
Clerk / Accountant .....	50,000.00

**§ 3. Employment and Appointment At Will.** Nothing contained in this Ordinance shall affect the right of Borough Council to dismiss any person appointed to an office or position of employment described herein at any time (unless otherwise provided by law or valid action of Borough Council) and nothing contained herein shall alter or affect the rights or procedures applicable to the dismissal of persons appointed to offices or positions of employment not specified in this Ordinance.

**§ 4. Duties.** All Borough officers and employees shall perform those duties assigned to them by law, by ordinance, resolution, or motion of Borough Council, and from

time to time by the President of Borough Council (or, in the case of the Police Department, by the Mayor).

**§ 5. Repealer.** Any Ordinance or part of an Ordinance conflicting with this Ordinance is repealed to the extent of the inconsistency.
