

**BOROUGH OF ALBURTIS  
LEHIGH COUNTY, PENNSYLVANIA**

Ordinance No. 415

(Duly Adopted October 29, 2003)

AN ORDINANCE ENACTING A RECODIFICATION AND REVISION OF ALL THE ORDINANCES OF THE BOROUGH, ENTITLED THE "CODIFIED ORDINANCES OF THE BOROUGH OF ALBURTIS," ADOPTED AS A SINGLE ORDINANCE SUPERSEDING ALL PRIOR ORDINANCES NOT SPECIFICALLY INCORPORATED THEREIN.

**WHEREAS**, Section 1008(b) of the Pennsylvania Borough Code, 53 PA. STAT. ANN. § 46008(b), authorizes Borough Council to adopt a consolidation, codification, or revision of the general body of Borough ordinances as a single ordinance in accordance with certain procedures; and

**WHEREAS**, Borough Council desires to recodify and revise all of the existing ordinances of the Borough, including those previously codified into the 1981 Code of the Borough of Alburdis, into a new codification entitled the "Codified Ordinances of the Borough of Alburdis"; and

**WHEREAS**, the recodification and revision was introduced in the Borough Council at its regular meeting on September 24, 2003; and

**WHEREAS**, notice of the introduction of the recodification and revision was advertised in the *East Penn Press*, a newspaper of general circulation in the Borough, on October 8, 2003, specifying its general nature and listing its table of contents;

**NOW, THEREFORE**, be it **ORDAINED** and **ENACTED** by the Borough Council of the Borough of Alburdis, Lehigh County, Pennsylvania, that the "Codified Ordinances of the Borough of Alburdis" as prepared by the Borough Solicitor is hereby adopted as the recodification and revision of all the Borough's ordinances, superseding all prior ordinances not specifically incorporated therein. The Borough Secretary shall maintain a

permanent copy of the “Codified Ordinances of the Borough of Alburtis,” as adopted by this Ordinance, separate and apart from future editions of the “Codified Ordinances of the Borough of Alburtis” which reflect amendments enacted after the date of this Ordinance. The Borough Solicitor shall publish a notice in the *East Penn Press* stating that this recodification and revision was finally enacted.
