Ordinance No. 438

(Duly Adopted December 28, 2005)

AN ORDINANCE AMENDING CHAPTER 53 OF THE ALBURTIS CODIFIED ORDINANCES (RELATING TO STREETS) TO MAKE IT UNLAWFUL TO GREASE, REPAIR, OR OTHERWISE SERVICE A VEHICLE UPON ANY STREET, OR TO PARK A VEHICLE UPON ANY STREET FOR THE PRINCIPAL PURPOSE OF GREASING, REPAIRING, OR OTHERWISE SERVICING SUCH VEHICLE, EXCEPT REPAIRS NECESSITATED BY AN EMERGENCY; PROVIDING PENALTIES (INCLUDING A FINE OF UP TO \$300.00); AND ADDING A CROSS-REFERENCE IN CHAPTER 41 OF THE ALBURTIS CODIFIED ORDINANCES (RELATING TO TRAFFIC CONTROL).

**BE** it **ORDAINED** and **ENACTED** by the Borough Council of the Borough of Alburtis, Lehigh County, Pennsylvania, as follows:

**SECTION 1.** Codified Ordinances Chapter 53 (relating to Streets) is amended by adding a new Article V thereto as follows:

**Article V — Greasing and Repairing Vehicles**

**§ 53-501 Prohibition.**

No person shall grease, repair, or otherwise service a vehicle upon any public street, road, highway, or alley, or park a vehicle upon any public street, road, highway, or alley for the principal purpose of greasing, repairing, or otherwise servicing such vehicle, except repairs necessitated by an emergency.

**§ 53-502 Violations and Penalties.**

(a) **In General.** Any person who violates any provision of this Article shall be guilty of a summary offense, and upon conviction therefor, shall be sentenced to pay a fine as set forth in subsection (b), plus the costs of prosecution, or, in default of payment, to undergo imprisonment for a period not to exceed thirty (30) days.

(b) **Fines.** The fine for any violation of this Article shall be—

(1) Seventy-five Dollars (\$75.00) for a first offense;

(2) One Hundred Fifty Dollars (\$150.00) for a second offense; and

(3) Three Hundred Dollars (\$300.00) for a third or subsequent offense.

**SECTION 2.** Codified Ordinances Chapter 41, Article XI (relating to Traffic Control—Other Regulations) is amended by adding a new section 41-1104 thereto as follows:

**§ 41- 1104 Cross-References.**

(a) **Greasing and Repairing Vehicles in Streets.** *See* Chapter 53, Article V (relating to Streets—Greasing and Repairing Vehicles).
