PUBLIC COMMENT - No Public Comment

MAYOR'S REPORT – Kathy Palmer mentioned that everyone has been made aware of our current police vehicle situation. If everyone remembers last year it was budgeted at the end of the year. Tony has one that is available, the company is aware of the situation and is willing to move us to the front of the line, the quote from Koch 33, it would be for 54,768. That's with it being ready to hit the road. If we can get the approval to move forward today, the other vehicle 902 has not been the greatest since it was involved in an accident a few years ago. Hector asked if he saw the numbers, but there were additional numbers that we were waiting to see regarding painting. Chief Tony Alsleben mentioned that the paint and decals would ultimately come to about \$1,500.00. Additional. The one thing with the Koch quote is that it would be ready to go, everything would be installed there. To expand on what the mayor said, we reached out to Whitmoyer and a few others, those places it would just be the car then you need to run around to get it outfitted. Koch has cars that should be in this week, they will take them to be painted then drop them off at the borough. This is normally the fleet ordering period of the year, so they have several orders coming in, we would be moved to the front if approved tonight. Ron asked what does the budget look like for now for a car. Steve Nemeth mentioned what we would like to do since we have not received the water pump invoice yet; take the water pump out of the water fund and take the car out of ARPA. Kathy mentioned that there is a grant that Steve and Tony are working on, so that we can use that for a vehicle next year. We can't keep running these vehicles on 7-10 years. Tony agrees with Kathy, what we should have been 3 marked vehicles because if one goes down, and 2 officers are working. The black unmarked can be used; but not ideal for patrol; that can be used for enforcement activities. Also, that is about 11 years old as well. What Steve and I are trying to do is get this grant so that it would give us that additional vehicle to put in the fleet which is very much needed. As you can see with what we are dealing with at the moment. If 902 goes down, not sure what we will be doing. Hector mentioned that you had mentioned that we had money set aside for this in the budget; Kathy said in the ARPA; if you remember Sharon said out of the ARPA funds in the final quarter. Hector asked so the money for the car would come out of the ARPA funds. Stephen and Kathy confirmed. Hector just to play devil's advocate; once we approved this to come out of the ARPA, and you said we are still waiting on the invoice for the water pump asked how much that was again; Stephen Nemeth said 67,000. Which would then come out of the water fund. Hector asked if we have enough in the water fund. Steve stated, yes, we have about \$476,700. John mentioned that we don't have money in ARPA for a vehicle. We used it all up with the police software, water pump, and playground equipment. John asked how much to pay for one vehicle. Kathy said 54,000. +1,500., so that would be around 57,000. John said you will say that we need it, but what we need to do is to watch how we spend. Kathy said what we need to do is keep a better rotation of the fleet, can't expect these cars to keep going 8-10 years. These are not like everyday vehicles. John said we don't need 3 vehicles for 2 officers; we don't have 6 maintenance trucks for 4 maintenances.

Request by AACC for remaining Alburtis Parade Funds-Ron Delaco mentioned last year when we did the parade, the borough itself did the parade; it is changing then we need to have a vote on that. Then say we are no longer running the parade. John mentioned that he believes this was already covered because the rec center does the parade. Ron does not argue if they are doing the parade the money should go to them; does not recall any motion that we said that we no longer would like to do the parade other than maybe a verbal. Hector mentioned that he would like to correct Ron's statement, last year the parade was not put on by the borough, if you remember correctly, you authorized myself to take charge of parade solo and independently from the borough. Then with volunteers were able to put the parade on these funds were solicited by myself and volunteers. Ron Delaco mentioned that money was then created and placed into a borough account. John Aleszczyk mentioned that last year the borough was not legally responsible for the parade, it was the rec center. Hector said no the rec center either, a group of volunteers and I put the parade together therefore it eliminated any liability on the borough. Ron DeIaco mentioned that so last year neither the borough of the AACC was liable for this. Ron asked Dave Knerr how does the borough legally hand over the money to the AACC. Dave asked what money it was. Kathy Palmer mentioned currently about \$995.53; is in there from donations in a separate line item. Dave Knerr mentioned you can just give it to anybody running the parade. John Aleszczyk mentioned last year we did this because it was just starting and to make it easy the borough just helped by creating a fund. Since it is now being run by AACC that will no longer be needed. John Aleszczyk mentioned that no monetary donation from the borough will be made for this by the borough, just the use of our staff. Chad Atkins made a motion to release remaining Halloween Parade funds to the AACC, the motion was 2nd by Steve Hill. Motion passes 4-0 with two members abstaining from voting.
