## § 40-1. Declaration of intent.

The Council of the Borough of Alburdis hereby signifies its intention and desire to organize an Authority under provisions of the Act of May 2, 1945, P.L. 382, known as the "Municipality Authorities Act of 1945," as amended and supplemented (hereinafter called the "Authorities Act"), for the purpose of exercising any and all powers conferred by the Authorities Act.<sup>1</sup>

## § 40-2. Articles of Incorporation.

The Mayor, President of Council and Secretary, respectively, of this borough hereby are authorized and directed to execute, on be-

half of this borough, Articles of Incorporation for such Authority in substantially the following form.<sup>2</sup>

**§ 40-3. Publication of notice.**

The Mayor, President of Council and Secretary, respectively, of this borough hereby are authorized and directed to cause notice of the substance of this chapter, including the substance of the foregoing Articles of Incorporation, and of the proposed filing of such Articles of Incorporation to be published once in a newspaper published and of general circulation in the County of Lehigh, Pennsylvania, and once in the legal journal published in and for the County of Lehigh, Pennsylvania, as required by the Authorities Act.<sup>3</sup>

**§ 40-4. Authorization to officials.**

The Mayor, President of Council and Secretary, respectively, of this borough hereby are authorized and directed to cause such Articles of Incorporation, together with necessary proofs of publication, to be filed with the Secretary of the Commonwealth of Pennsylvania, and to do all other acts and things necessary or appropriate to effect the incorporation of such Authority, including payment of any filing fees necessary in connection therewith.

**§ 40-5. Appointment of members.**

The following named persons shall be and they hereby are appointed as first members of the Board of the Authority for the following terms of office:
