ORDINANCE NO. 304

AN ORDINANCE FIXING THE SALARIES, BONDS AND DUTIES OF  
BOROUGH OFFICIALS AND EMPLOYEES FOR THE YEAR 1994.

BE IT ORDAINED AND ENACTED by the Borough Council for the  
Borough of Alburtis as follows:

SECTION 1: The following rates of compensation are hereby  
established for the year 1994 for the offices and positions of

SECTION 3: Nothing contained in this Ordinance shall affect the right of Borough Council to dismiss any person appointed to an office or position of employment described herein at any time (unless otherwise provided by law, or an ordinance, resolution, or other action of Borough Council), and nothing contained herein shall alter or affect the rights or procedures applicable to the dismissal of other appointees.

SECTION 4: Any ordinance conflicting in whole or in any part with this Ordinance is hereby repealed.


