Ordinance No. 320

(Duly Enacted November 29, 1995)

AN ORDINANCE INCREASING THE ANNUAL SALARY OF MEMBERS OF BOROUGH COUNCIL AND THE MAYOR TO ONE THOUSAND FIVE HUNDRED DOLLARS (\$1,500.00), EFFECTIVE JANUARY 1, 1996 WITH RESPECT TO THE MAYOR AND EFFECTIVE ON THE FIRST DAY OF A NEW TERM OF OFFICE COMMENCING AFTER JANUARY 1, 1996 WITH RESPECT TO MEMBERS OF BOROUGH COUNCIL.

**WHEREAS**, under Section 1001 of the Borough Code, 53 PA. STAT. ANN. §46001, Council members of a borough may receive compensation to be fixed by ordinance in a maximum amount of One Thousand Five Hundred Dollars (\$1,500) per year for boroughs with a population less than five thousand (5,000), but may not exceed the compensation of the mayor; and

**WHEREAS**, under Sections 1024 and 1025 of the Borough Code, 53 PA. STAT. ANN. §§46024 and 46025, the Mayor of a borough may receive compensation to be fixed by ordinance in a maximum amount of Two Thousand Dollars (\$2,000) per year for boroughs with a population less than five thousand (5,000);

**NOW, THEREFORE**, be it **ORDAINED** and **ENACTED** by the Borough Council of the Borough of Alburdis, Lehigh County, Pennsylvania, as follows:

**§ 1 Compensation of Members of Borough Council.**

The compensation of members of Borough Council shall be One Thousand Five Hundred Dollars per year, payable in monthly installments.

**§ 2 Compensation of the Mayor.**

The compensation of Mayor of this Borough shall be One Thousand Five Hundred Dollars per year, payable in monthly installments.

**§ 3 Effective Date.**

(a) Section 1 of this Ordinance shall be effective for any given member of Borough Council on the first day after January 1 1996 that the member begins a new term of office.

(b) Section 2 of this Ordinance shall be effective January 1 1996.
