Ordinance No. 425

(Duly Adopted July 14, 2004)

AN ORDINANCE AMENDING SECTION 41-802 OF THE ALBURTIS CODIFIED ORDINANCES TO DESIGNATE A HANDICAPPED PARKING SPACE ON THE EAST SIDE OF WALNUT STREET IN FRONT OF 231 WALNUT STREET UNTIL JUNE 30, 2005, UNLESS TERMINATED SOONER BY COUNCIL; AND AMENDING SECTION 11-107(a) OF THE ALBURTIS CODIFIED ORDINANCES TO INCREASE THE MONTHLY COMPENSATION OF THE ZONING OFFICER BY ONE HUNDRED DOLLARS.

WHEREAS, Borough Council has received an application for a handicapped parking space in front of 231 Walnut Street to accommodate the parking needs of a person with a disability; and

WHEREAS, Council desires to establish such a handicapped parking space for a limited period of time; and

WHEREAS, Council desires to increase the compensation payable to the Borough Zoning Officer; and

WHEREAS, on July 7, 2004, the Borough published a public notice in the *East Penn Press*, a newspaper of general circulation in the Borough of Alburtis, of its intention to consider and adopt on this Ordinance on July 14, 2004;

NOW, THEREFORE, be it **ORDAINED** and **ENACTED** by the Borough Council of the Borough of Alburtis, Lehigh County, Pennsylvania, as follows:

SECTION 1. Codified Ordinances § 41-802 (relating to Traffic Control—Handicapped Parking Spaces—Designated Spaces) is amended as follows (with deletions indicated by ~~strike-outs~~ and insertions indicated by double underlining):

§ 41-802 Designated Spaces.

The following spaces are designated handicapped parking spaces. A particular disabled person is identified for each space, and the designation shall remain in effect until the expiration date for that space, unless terminated sooner by motion or resolution of Council. Unless otherwise indicated below, the length of the space shall be twenty-two (22) feet, and the center of the space shall be the point where the street curblin intersects the center-line of the sidewalk or other access-way used by the disabled person to access the dwelling on the designated property:

SECTION 2. Codified Ordinances § 11-107(a) (relating to Salaries and Compensation—In General—Codes Enforcement—Zoning Officer) is amended as follows (with deletions indicated by ~~strike-outs~~ and insertions indicated by double underlining):

§ 11-107 Codes Enforcement.

(a) Zoning Officer.

(1) 1/1/2003. ~~Effective~~ From January 1, 2003 to June 30, 2004, the compensation of the Zoning Officer shall be \$200.00 per month plus \$5.00 for each permit issued.

(2) 7/1/2004. Effective July 1, 2004, the compensation of the Zoning Officer shall be \$300.00 per month plus \$5.00 for each permit issued.
