Ordinance No. 426

(Duly Adopted September 29, 2004)

AN ORDINANCE AMENDING SECTION 41-802 OF THE ALBURTIS CODIFIED ORDINANCES TO DESIGNATE A HANDICAPPED PARKING SPACE ON THE EAST SIDE OF WALNUT STREET IN FRONT OF 329 WALNUT STREET UNTIL SEPTEMBER 30, 2005, UNLESS TERMINATED SOONER BY COUNCIL, AND A HANDICAPPED PARKING SPACE ON THE WEST SIDE OF CHESTNUT STREET BETWEEN FRONT STREET AND WEST SECOND STREET NEAR THE ENTRANCE TO 103 WEST SECOND STREET.

WHEREAS, Borough Council has received applications for two handicapped parking spaces to accommodate the parking needs of persons with a disability; and

WHEREAS, Council desires to establish such handicapped parking spaces for a limited period of time;

WHEREAS, on September 22, 2004, the Borough published a public notice in the *East Penn Press*, a newspaper of general circulation in the Borough of Alburttis, of its intention to consider and adopt on this Ordinance on September 29, 2004;

NOW, THEREFORE, be it **ORDAINED** and **ENACTED** by the Borough Council of the Borough of Alburttis, Lehigh County, Pennsylvania, as follows:

SECTION 1. Codified Ordinances § 41-802 (relating to Traffic Control—Handicapped Parking Spaces—Designated Spaces) is amended as follows (with deletions indicated by ~~strike-outs~~ and insertions indicated by double underlining):

§ 41-802 Designated Spaces.

The following spaces are designated handicapped parking spaces. A particular disabled person is identified for each space, and the designation shall remain in effect until the expiration date for that space, unless terminated sooner by motion or resolution of Council. Unless otherwise indicated below, the length of the space shall be twenty-two (22) feet, and the center of the space shall be the point where the street curblin intersects the center-line of the sidewalk or other access-way used by the disabled person to access the dwelling on the designated property:

3.	<u>Fay Oels</u>	<u>September 30, 2005</u>	<u>Chestnut Street, Westerly Side</u>	<u>From the point sixty (60) feet north of the northern curblin of West Second Street, to the point twenty-two (22) feet north of the starting point.</u>
