BOROUGH OF ALBURTIS LEHIGH COUNTY, PENNSYLVANIA

Ordinance No. 452

(Duly Adopted December 27, 2006)

AN ORDINANCE ESTABLISHING THE REAL ESTATE TAX RATE FOR THE FISCAL YEAR 2007 AT 9.4 MILLS, WHICH REPRESENTS A 1.0 MILL INCREASE OVER THE RATE APPLICABLE FOR 2006; CONFIRMING WITH NO INCREASE IN RATES FOR 2007 THE PER CAPITA TAX, EARNED INCOME TAX, EMERGENCY AND MUNICIPAL SERVICES TAX, REALTY TRANSFER TAX, WATER RATES AND CHARGES, SEWER RATES AND CHARGES, AND GARBAGE FEES; AND EXTENDING THE SANITARY SEWER TEMPORARY SURCHARGE FOR 2007 AT THE SAME RATE AS FOR 2006.

BE IT ORDAINED and **ENACTED** by the Borough Council of the Borough of Alburtis, Lehigh County, Pennsylvania, as follows:

SECTION 1. Chapter 81 of the Codified Ordinances (relating to Real Property Tax) is amended by adding the following new § 81-109:

§ 81-109 2007.

A tax is hereby levied on all assessed property within the Borough of Alburtis subject to taxation for fiscal year 2007, as follows:

- (a) For general borough purposes, the sum of 9.4 mills on each dollar of assessed valuation.
- **(b)** The total tax levy on assessed property is equal to 9.4 mills on each dollar of assessed valuation.

SECTION 2. Codified Ordinances § 81-201 (relating to Real Property Tax—Penalties) is ratified and confirmed for fiscal year 2007.

SECTION 3. The rates of taxes under Chapters 82 (relating to Earned Income

Tax), 83 (relating to Per Capita Tax), and 84 (relating to Emergency and Municipal

Services Tax), of the Codified Ordinances are ratified and confirmed without change for

the year 2007. The rate of tax under Chapter 85 (relating to Realty Transfer Tax) is also

unchanged for the year 2007, although certain other provisions of the Chapter have been

amended by Ordinance 451 (adopted December 27, 2006).

SECTION 4. The rentals, charges, and/or fees established under Codified Ordi-

nances Chapter 64, Article VI (relating to Water Rentals, Charges, and Fees), Chapter 65,

Article V (relating to Sewer Rental & System Usage Fees), and Chapter 67, Article VII

(relating to Municipal Solid Waste, Recyclables, and Other Refuse—Fees) are ratified

and confirmed without change for the year 2007.
